**NOTICE TO BIDDERS**

NOTICE is hereby given that sealed bids will be received by The Somerset Raritan Valley Sewerage Authority (the "Authority"), at its offices located at 50 Polhemus Lane, Bridgewater, New Jersey, on **September 13, 2018 at 2:00 p.m.**, for:

**FURNISHING AND DELIVERY OF LIQUID SODIUM HYDROXIDE -  
50% SOLUTION**

No bids shall be received other than at the time and place herein designated for their receipt, unless mailed to the Authority for receipt at the designated time and place. At the time and place herein designated, the sealed bids will be publicly opened and read aloud.

Each bid must be submitted in writing on the forms furnished by the Authority in the bid package and prepared and submitted in the manner designated therein. On or after **August 24, 2018** the bid package may be obtained at the office of the Authority indicated above, during regular business hours for a non-refundable fee of \$7.00.

The Work under this procurement shall include furnishing, without limitation, all labor, equipment, materials and all other items or services necessary and/or required for the performance of the **FURNISHING AND DELIVERY OF LIQUID SODIUM HYDROXIDE - 50% SOLUTION**. The term of the contract shall be for a period anticipated to commence on January 1, 2019 and shall continue through December 31, 2019.

A certified check, cashier's check or bid bond in the amount of ten (10%) of the total bid amount but not in excess of or \$20,000.00, whichever is lower, must be submitted with the bid as a guaranty that if a contract is awarded, the Bidder shall execute the Contract required by the Contract Documents. Where the specifications require, a Consent of Surety in the amount equal the one hundred and ten percent (110%) of the Contract Price will be required. If a Bid Bond and/or a Consent of Surety is being submitted, sureties shall be licensed and/or authorized to transact business in the State of New Jersey and acceptable to the Authority. Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et.seq. and N.J.A.C.

17:27 (Affirmative Action Program, Equal Employment Opportunity), and Americans with Disabilities Act of 1990(42 U.S.C. S12.101 et seq.), as applicable. Additionally, a copy of the Business Registration Certificate issued by the New Jersey Department of Treasury, Division of Revenue, for the bidder must be submitted in conformance with P.L. 2004, c.57.

The Successful Bidder shall be required to comply with all provisions of the New Jersey Prevailing Wage Act, as determined by the New Jersey Department of Labor and Industry.

Bids must be prepared and submitted in the manner designated, and shall also be accompanied by the other information requested, in the documents contained in the bid package. Each bid shall be enclosed in a sealed envelope addressed to the Executive Director of the Authority, bearing the name and address of the Bidder, upon which shall be designated:

The Authority expressly reserves the right to reject any and all bids, to waive any informalities and/or to accept the bid which, in its judgment, shall be in the best interest of the Authority, all in accordance with the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1 et. seq.
