WHEREAS, The Somerset Raritan Valley Sewerage Authority has an established Industrial Pretreatment Program to allow for and regulate the discharge of industrial effluent and/or groundwater via a permit program; and,

WHEREAS, the Township of Hillsborough is requesting that The Somerset Raritan Valley Sewerage Authority reissue them a Groundwater Discharge Permit for a remediation project that is located at the Department of Public Works Garage at 21 East Mountain Road, (Block 12, Lot 23) Hillsborough. The Township is extracting groundwater from a former gasoline Underground Storage Tank Excavation. The Permit, if approved, will be effective for five years; and

WHEREAS, the owner of this site has agreed to abide by all the rules and regulations of the Authority concerning the discharge of groundwater to the Authority's system; and

WHEREAS, a thirty-day Public Comment Period was held to receive written comments or to request that the SRVSA hold a non-adversarial Public Hearing. No comments were received from the public during the Public Comment Period. There were no requests for a non-adversarial Public Hearing.

NOW, THEREFORE, BE IT RESOLVED by The Somerset Raritan Valley Sewerage Authority that it hereby authorize the reissuance of a Groundwater Discharge Permit to the Township of Hillsborough, for the Department of Public Works Garage site, located at 21 East Mountain Road, Hillsborough, New Jersey.



The facility has applied to the SRVSA for a renewal of its discharge permit. The permit will regulate the groundwater discharge from the remediation site and if approved, will be effective for five years.

Written comments or a request that the SRVSA hold a non-adversarial public hearing on the proposed permit modification must be submitted in writing to Glen D. Petrauski, Executive Director, SRVSA, PO Box 6400, Polhemus Lane, Bridgewater, New Jersey 08807-0400, by the close of the public comment period, which closes thirty calendar days after the publication of this notice in the newspaper. All persons, including the permittee, who believe that the SRVSA's decision to reissue the permit is inappropriate, must raise all reasonable ascertainable arguments and factual grounds supporting their position, including all supporting material during the public comment period.

If no comments are received during this period, the Somerset Raritan Valley Sewerage Authority intends to take action regarding this issue at its June 24, 2013 meeting at 7:30 PM. **WHEREAS**, The Somerset Raritan Valley Sewerage Authority ("the Authority") has an existing 36-inch diameter magnetic flow meter mounted in the dry-pit side of the Influent Pumping Station, which was installed as part of the Comprehensive Strategic Plan-Phase I Project; and

**WHEREAS**, the existing flowmeter had sustained permanent damage due to dry-pit flooding caused by Tropical Storm Irene in August of 2011; and

**WHEREAS**, this damage was made part of the Authority's claim to FEMA for 75% reimbursement, in the replacement amount of \$33,600; and

**WHEREAS**, in accordance with the Local Public Contracts Law, N.J.S.A.: 40:11-1 et. seq., the Authority is required to seek public bids for any product or service costing in excess of \$17,500; and

**WHEREAS**, in accordance with the Local Public Contracts Law, N.J.S.A.: 40:11-1 et. seq., on Thursday, May 16<sup>th</sup>, 2013 sealed bids were publicly received and opened by the Authority for the **PURCHASE, REMOVAL AND INSTALLATION OF ONE (1) 36-INCH ABB WASTEWATER MAGNETIC FLOWMETER**. Four bids were received, and upon a review of the bidding documents by the Authority's staff, it was determined that Allied Construction Group, Inc. submitted all of the required documents and was the lowest bid and should, therefore, be awarded the bid for a total amount of \$44,940.00.






