Air Liquide Advanced Materials, Inc. is located at 197 Meister Avenue in Branchburg, New Jersey. Air Liquide Advanced Materials, Inc. has applied to the Somerset Raritan Valley Sewerage Authority (SRVSA) for the renewal of Non-Domestic Wastewater Discharge Permit 37. The permit renewal will allow Air Liquide Advanced Materials, Inc. to continue to discharge wastewater generated at the facility from the production of specialty gases. If approved, the permit will be effective for five years.

Air Liquide Advanced Materials, Inc. is regulated as a Significant Industrial User due to the Biochemical Oxygen Demand, Chemical Oxygen Demand and Total Dissolved Solids loading present in the discharge. Air Liquide Advanced Materials, Inc. performs the following pretreatment: pH adjustment of the specialty gas process waste stream (Sampling Site 003).

Public notice regarding this permit renewal was issued on June 3, 2019. No comments from either the public or Air Liquide Advanced Materials, Inc. were received during the Public Comment Period, which closed on July 2, 2019.

WHEREAS, an application has been received from Bridgewater Township for construction of a sewer collection system and a sewer connection to the appropriate Bridgewater Township line or lines to allow the discharge of sewage to be received and treated at and by the facilities of The Somerset Raritan Valley Sewerage Authority, and

WHEREAS, the applicant calculated an additional discharge a flow of 70,000 gpd from a proposed additional sausage casing manufacturing line inside an existing building that is connected to the Bridgewater Township's sanitary sewer; and

WHEREAS, the project is located at 141 Southside Avenue and does not include the construction of additional sewer lines; and

WHEREAS, the developer/applicant in not required to provide a Connection Fee Agreement or pay an additional connection fee to the Authority since the project was initiated prior to the enactment of a new law that allows The Somerset Raritan Valley Sewerage Authority to charge an additional fee if the developer/applicant materially increases the level of use or demand on the sewerage system; and

WHEREAS, said application has been reviewed for conformance with the applicable wastewater management plans and documents and available permitted design treatment capacity, only, and is recommended for approval by, Sherwin Ulep, P.E., the Authority Engineer;

BE IT RESOLVED BY THE SOMERSET RARITAN VALLEY SEWERAGE AUTHORITY that it hereby consents to the construction of the above stated collection and conveyance systems, such consent being in accordance with the provisions of R.S.40:14A-29; and

BE IT FURTHER RESOLVED that The Somerset Raritan Valley Sewerage Authority does hereby approve the Application of Bridgewater Township to connect to the Bridgewater Township collection system and to deliver sewage to the facilities of The Somerset Raritan Valley Sewerage Authority, subject to further approval of the New Jersey Department of Environmental Protection; and

BE IT FURTHER RESOLVED this approval is not, nor shall it be construed to be, an allocation or guarantee of future capacity, and, further, that the connection fee or fees in effect at the time such connection is to be made shall be paid to the Authority in accordance with the Authority's regulations pertaining thereto and the terms of a Connection Fee Agreement entered into by and between the Applicant and the Authority on or before the date of adoption of this Resolution; and

BE IT FURTHER RESOLVED this consent and approval will terminate if Applicant fails to complete construction of said collection facilities and to make connection thereof and commence delivery of sewage to the facilities of The Somerset Raritan Valley Sewerage Authority within two (2) years of the date hereof; and the Department of Environmental Protection is hereby notified that all time extension requests of this consent and approval must be approved by the Authority.
