PURCHASE OF THREE (3) NEW ACCUSONIC FLOWMETERS

As a result of the flooding caused by Hurricane Ida, three of the Authority's Accusonic Transit-Time flowmeters were damaged beyond repair. As further described in Manager of Engineering Ulep's attached memo, we have received reimbursement of 90% of the cost of these flowmeters from the Federal Emergency Management Agency (FEMA), in the amount of \$123,616.80.

In recent years, Sherwin and I have been exploring to find a suitable replacement metering technology. While we are in the process of demonstrating a new type of flow metering technology, we have realized that the Accusonic meters are a very accurate and reliable technology and have been in use for over 25 years at the Authority, and we plan for our metering system going into the future to include the Accusonic meters as well as other technologies.

I recommend to the Board of Commissioners authorize the purchase of three (3) Accusonic flow meter consoles in the amount of \$137,112.00.

Furnishing of the Replacement Accusonic Area Velocity Flow Meter Consoles for

MC 9Hp, 10R and 10B

During the September 2021 flooding caused by Hurricane Ida, three (3) of the Authority's Accusonic transit-time flow meter consoles were damaged beyond repair and six (6) other consoles sustained partial damage. Throughout the following months, Allied Control Services (ACS) was able to repair all six (6) partially damaged consoles to some extent using the Authority's remaining stock spare parts. Although these meters have been repaired, some of the consoles' functions remain inoperable. The Authority also used its last two (2) remaining spare Accusonic consoles as a replacement for the completely damaged units. The Authority has not been able to furnish replacement parts for these consoles since Accusonic has stopped supporting such older models a few years ago.

The Authority staff applied and received Federal Emergency Management Agency (FEMA) assistance in the amount of \$123,616.80. This amount is 90% of the total price of \$135,762.00 to furnish three (3) new Accusonic 8510 consoles at \$45,254.00 per console (see attached ACS quotation). This means that with the FEMA assistance, the cost of the Authority will only be \$4,498.40 per console, including freight.

The Authority has refrained last year from furnishing the new replacement consoles in the hopes find a cheaper alternative to the Accusonics system. The Authority is currently performing a long-term evaluation of the ISCO LaserFlow demonstration unit to see if it can be a viable replacement.

Unfortunately, the existing Accusonic consoles have started to fail beyond repair and the LaserFlow has not yet been completely evaluated. With no available spare consoles and parts, the Authority will have no way to accurately measure flows during severe wet-weather conditions in some of its meter chambers.

As such, I recommend that the Authority furnish three (3) Accusonic flow meter consoles in the amount of \$137,112.00. Accusonic is the sole manufacturer of all replacement components and ACS is the sole source representative in New Jersey (see attached letter from ADS, LLC).
