WHEREAS, regulations of the State of New Jersey Local Finance Board (N.J.A.C. 5:31) require each local Authority to adopt a Cash Management Plan;

NOW, THEREFORE, BE IT RESOLVED by The Somerset Raritan Valley Sewerage Authority that the attached Cash Management Plan be designated as the authoritative source for the Authority's; Cash Receipts, Depositories, Payment of Claims, Cash Disbursements, Payroll Check Disbursements Over \$5,000 & Sets Authority Delineating Responsibility & Rights to Manage the Cash Management Plan.

**SOMERSET RARITAN VALLEY SEWERAGE AUTHORITY
CASH MANAGEMENT PLAN**

GOVERNING AUTHORITY

The cash management plan shall be operated in conformance with the State of New Jersey Local Fiscal Affairs Law (N.J.S.A. 40A: 5) and the Somerset Raritan Valley Sewerage Authority (hereinafter referred to as SRVSA or the Authority) Resolution Authorizing the Issuance of Revenue Bonds of the SRVSA adopted March 26, 1958 and later amended in 1977 (hereinafter referred to as Bond Resolution).

ADMINISTRATION

The Chief Financial Officer shall be responsible for administering the Cash Management Plan.

INTERNAL CONTROLS

The Executive Director and Chief Financial Officer are responsible for establishing and maintaining an internal control structure designed to ensure that the assets of the SRVSA are protected from loss, theft, or misuse. The internal control structure shall be designed to provide reasonable assurance that these objectives are met. The concept of reasonable assurance recognizes that (1) the cost of a control should not exceed the benefits likely to be derived and (2) the valuation of costs and benefits requires estimates and judgments by management. Details of the internal control system shall be set forth in a procedures manual which shall be approved by resolution of the Authority.

RESOLUTION ESTABLISHING A CASH MANAGEMENT PLAN FOR AUTHORITY FUNDS AND INVESTMENTS DESIGNATED DEPOSITORIES

CASH RECEIPTS

All moneys received by the Authority from any source shall, within 48 hours, be deposited to the credit of the Authority in a designated depository in interest bearing accounts.

Designated depositories for the cash and investments of the Authority must be New Jersey banks approved by the Department of Banking and Insurance under the Government Unit Deposit Protection Act (GUDPA), the bank appointed as trustee bank for the bondholders, or the New Jersey State Cash Management Fund. The designated depositories shall be:

CLAIMS

All claims for payment shall include a certification of the party claiming payment that it is correct; a certification by the Executive Director/Certifying Officer that the goods have been received by, or the services rendered to the Authority; and shall be approved or disapproved for payment by the members of the Authority at a regular meeting.

CASH DISBURSEMENTS

All disbursements of the Operating Fund, Construction Fund, Connection Fund and General

Fund shall be made by checks signed by any two of the following officials: Chairman, Vice-Chairman, Treasurer, and/or Secretary and countersigned by the Executive Director.

Salaries and wages are to be paid by checks disbursed from the Payroll Account on a bi-weekly basis and said checks to be signed by the Chairman, Executive Director, or in the absence of the Executive Director, the Assistant Executive Director/Manager of Engineering or the Chief Financial Officer.

Payroll checks in excess of \$5,000.00 must be executed in accordance with the normal three (3) signature requirement of the Authority.

INVESTMENTS

Delegation of Authority

Authority to manage the investment program is granted to the Chief Financial Officer and Executive Director hereinafter referred to as Investment Officer. The Investment Officer shall act in accordance with the established written procedures, policies and internal controls of the cash management plan and stay consistent with the investment policy established herein.

Authorized Signatures/Account Signors

To facilitate the flow of money for investment purposes, signatures of the following employees shall be considered Authorized Signatures/Account Signors: Executive Director and the Chief Financial Officer or Assistant Executive Director/Manager of Engineering. Two Authorized Signatures/Account Signors are required to purchase investments, to open or close bank accounts or withdraw money from any account. The transfer of money between accounts of the Authority shall be upon Resolution adopted by the Authority or by requisition with two authorized signatures/account signors. However, the transfer of money between bank accounts within the same fund (i.e. Connection Savings to Connection Checking) and within the same banking institution can be accomplished by way of approved online banking transfer. The HR Manager shall be authorized to make transfers between the Operating Account, the Payroll Account and the Flexible Spending Account, all of which are within the Operating Fund.

The State Cash Management Fund requires participants to call State Street Bank and Trust to deposit funds and withdrawal funds. The Authority submits an application linking an account(s) established within the State Cash Management Fund in the Authority's name to a single bank account at an approved Authority depository bank. This cannot be changed without a new board resolution and application. Based on this internal control, the State Cash Management Fund requires one person to affect a wire transfer and the Authority's policy of having two authorized signatures/account signors must be suppressed for this one particular purpose. Also, the State Cash Management Fund recognizes authorized signors by name, not title, so the application and resolution are by specific name for this one particular purpose.

RESOLUTION ESTABLISHING A CASH MANAGEMENT PLAN FOR AUTHORITY FUNDS AND INVESTMENTS DESIGNATED DEPOSITORY

Objectives

The primary objectives, in priority order, of investment activities shall be safety, liquidity, and yield.

Safety

The preservation of the moneys of SRVSA shall be the top priority and moneys shall be deposited or invested in full compliance with all laws, regulations, bond covenants and this cash management plan.

Liquidity

The investment portfolio shall remain sufficiently liquid to meet all operating and capital requirements that may be reasonably anticipated. The investment portfolio shall be structured so that securities mature concurrent with cash needs to meet anticipated demands. Since all possible cash demands cannot be anticipated, the portfolio should maintain a sufficient balance of deposits or investments convertible to cash within two business days.

Yield

The investment portfolio shall be designed with the objective of attaining a market rate of return throughout budgetary and economic cycles, taking into account the investment risk constraints and liquidity needs. The Investment Officer shall seek to mitigate interest rate risk by purchasing investments with different lengths of maturity. Return on investment is of secondary importance compared to the safety and liquidity objectives described herein. Investments shall be made on a competitive basis insofar as practical.

Standards of Care

Prudence

The standard of prudence to be used by investment officials shall be the prudent person standard and shall be applied in the context of managing an overall portfolio. The prudent person standard states that, "Investments shall be made with judgment and care, under circumstances then prevailing, which persons of prudence, discretion and intelligence exercise in the management of their own affairs, not for speculation, but for investment, considering the probable safety of their capital as well as the probable income to be derived."

Ethics and Conflicts of Interest

Employees involved in the investment process shall refrain from personal business activity that could conflict with the proper execution and management of the investment program, or that could impair their ability to make impartial decisions. Employees shall disclose any material

interests in financial institutions with which they conduct business. Employees shall refrain from undertaking personal investment transactions with the same individual with whom business is conducted on behalf of the SRVSA.

Authorized Investment Depositories

Deposits and purchases of certificates of deposits shall be made with designated depositories as previously defined in this document.

Authorized Investments

- Money Held by the Trustee

The permitted investment of money held by the trustee is as defined by the SRVSA Resolution authorizing the Issuance of Sewer Revenue Bonds of the SRVSA Adopted March 26, 1958 and amended in 1977 as follows:

“(a) any direct and general obligation of, or any obligation fully and unconditionally guaranteed by, the United States of America, or (b) any bond, debenture, note or participation certificate fully and unconditionally guaranteed by the United States of America and issued by any of the following federal agencies: Bank for cooperatives, Federal Intermediate Credit Banks, Federal Home Loan Bank System, Federal Land Banks, Export- Import Bank of the United States, Tennessee Valley Authority, Federal National Mortgage Association, Government National Mortgage Association, Federal Financing Bank, Student Loan Marketing Association, Farmers Home Administration, Federal Home Loan Mortgage Corporation, United States Postal Service, or any other agency or corporation which has been or may hereafter be created by or pursuant to an Act of the Congress of the United States as an agency or instrumentality thereof, or (c) negotiable or non-negotiable certificates of deposit or time deposits issued by any bank, trust company or national banking association which is a member of the Federal Reserve System and the deposits of which are insured by the Federal Deposit Insurance Corporation, or any State or Federally chartered savings and loan association the deposits of which are insured by the Federal Savings and Loan Corporation, provided that (unless such certificates of deposit or time deposits are fully insured or guaranteed by the Federal Deposit Insurance Corporation or the Federal Savings and Loan Insurance Corporation) such certificates of deposit or time deposits are secured by obligations described in clause (a) or clause (b) above, all of which obligations, valued at the market rate, shall be at least 110% of the amount of the deposit in excess of the amount insured by the Federal Deposit Insurance Corporation or the Federal Savings and Loan Insurance Corporation, which certificates of deposit shall be purchased directly from such a bank, trust company, national association or savings and loan association, or (d) any public housing bond issued by a public housing authority and fully secured as to the payment of both principal and interest by a pledge of annual contributions under an annual contribution contract or contracts with the United States of America, or temporary note issued by a public housing authority or preliminary loan note issued by a local public agency, in each case,

fully secured as to the payment of both principal and interest by a requisition or payment agreement with the United States of America.”

The N.J. State Cash Management Fund does not qualify to receive SRVSA money held by the trustee. The Authority does have the right to direct the trustee to purchase certificates of deposit (CD) in banks that are Designated Depositories. The Authority can direct the trustee to deposit funds in a Designated Depository up to the maximum threshold set by the Federal Deposit Insurance Corporation (FDIC). The Authority can direct the trustee to purchase CD's with multiple Designated Depositories. It shall be the Authority's policy not to participate in collateralization of CD's over the FDIC maximum insurance threshold.

- Money Not Held by Trustee

The permitted investment of money not under the control of the trustee is as specified by N.J.S.A. 40A:5-15-1(a) as attached hereto.

REPORTING

The investment officer shall prepare an investment report monthly, including a management summary that provides an analysis of the status of the current investment portfolio and the individual transactions executed over the last month. This management summary will be prepared in a manner which will allow the reader to ascertain whether investment activities during the reporting period have conformed to the cash management plan. The report shall be provided to the Executive Director and the Board of Commissioners on a monthly basis.

The report shall be provided to the Executive Director and the Board of Commissioners on a monthly basis. The report will include the following:

- Listing of investments held at the end of the reporting period in which the name of any institution holding funds shall be specified, purchase date and maturity date shall be specified for each investment.
- The amount of securities or deposits purchased or sold during the immediately preceding month along with the class or type of investment purchased.
- The expected weighted yield to maturity of the entire portfolio as well as the yield to maturity for each investment.
- Percentage of the total portfolio each investment class represents.
- A comparison of the budget revenue to be realized with the budgetary expectations.





**RESOLUTION DESIGNATING CHIEF FINANCIAL OFFICER PETER WOZNIAK
AS THE QUALIFIED PURCHASING AGENT**

WHEREAS, the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq., provides that the governing body of any contracting unit may designate an employee as Purchasing Agent having the authority, responsibility and accountability for the purchasing activity for the contracting unit, and who possesses a Qualified Purchasing Agent (QPA) certificate; and

WHEREAS, the Board of Commissioners of the Somerset Raritan Valley Sewerage Authority desires to designate a Purchasing Agent to oversee the preparation of public advertising for bids, to receive bids, to solicit competitive quotations when required, and to award contracts in the name of the Authority; and

WHEREAS, the Local Public Contracts Law provides that when the contracting unit has designated an employee as Purchasing Agent who, as defined by the law shall possess a QPA certificate, the cost or price of any contract awarded by the Purchasing Agent in the aggregate does not exceed in a contract year the total sum of the bid threshold established under P.L. 2009, c. 166 (presently \$53,000), where the contract may be awarded by the Purchasing Agent when so authorized by Resolution, as appropriate to the contracting unit, of the governing body of the contracting unit without public advertising for bids; and

WHEREAS, Chief Financial Officer Peter Wozniak has successfully completed the State of New Jersey Qualified Purchasing Agent examination that was administered on December 8, 2014; and

WHEREAS, the Board of Commissioners of the Somerset Raritan Valley Sewerage Authority desires, in the interest of efficiency and expediency, to grant a general delegation of power to a designated Purchasing Agent to negotiate and award all contracts having an aggregate total sum per year of less than \$53,000 in accordance with the Local Public Contracts Law.

NOW, THEREFORE, BE IT RESOLVED by the Somerset Raritan Valley Sewerage Authority Board of Commissioners that Chief Financial Officer Peter Wozniak is hereby designated as the Purchasing Agent for the Authority and may perform, under the supervision of the Executive Director, the functions and duties of a Purchasing Agent for the Authority independently; and

Such contracts include, but are not limited to emergency contracts, contracts for materials, supplies, equipment, delivery of goods, and performance of services, including professional services; and

BE IT FURTHER RESOLVED that, under the supervision of the Executive Director, the Purchasing Agent shall oversee the solicitation of competitive quotations when required under the Local Public Contracts Law, conduct any activities as may be necessary or appropriate to the purchasing function of the Authority, and oversee the award of all contracts authorized by this Resolution in accordance with the provisions of the Local Public Contracts Law; and

BE IT FURTHER RESOLVED that, under the direction of the Executive Director, the Purchasing Agent is authorized to oversee the preparation of public advertising for bids and to receive bids for the provision or performance of goods or services on behalf of the Authority, the cost of which in the aggregate exceeds the bid threshold as established under P.L. 2009, c. 166 (presently \$53,000), as may be amended from time to time, however, in no event will a contract exceeding the bid threshold be awarded without a separate Resolution of the Board of Commissioners designating the lowest responsible bidder; and

BE IT FURTHER RESOLVED that in the event that the Board desires to use competitive contracting in lieu of public bidding for procurement of specialized goods or services enumerated in section 1 of P.L. 1999, c. 440, above the bid threshold established under P.L. 2009, c. 166 (presently \$53,000), in order to initiate competitive contracting, the Authority shall adopt a Resolution authorizing the use of competitive contracting each time specialized goods or services enumerated in section 1 of P.L. 1999, c. 440 are desired to be contracted. However, if the desired goods or services have previously been contracted for using the competitive contracting process then the original Resolution of the Authority shall suffice.

**RESOLUTION ESTABLISHING THE AUTHORITY'S POLICY
REGARDING CONFERENCE ATTENDANCE**

WHEREAS, the Association of Environmental Authorities, the Water Environment Federation and other groups regularly schedule conferences and seminars designed to disseminate technical, management and regulatory information to appointed members and employees of public sewerage authorities; and

WHEREAS, attendance at such conferences and seminars is beneficial to appointed members and employees in fulfilling their responsibilities in the management and operation of The Somerset Raritan Valley Sewerage Authority; and

WHEREAS, limited funds are available for such purposes in the annual operating budget of the Authority.

NOW, THEREFORE, BE IT RESOLVED by The Somerset Raritan Valley Sewerage Authority that the following policy governing attendance and expenses for conferences and seminars be adopted:

CONFERENCE AND SEMINAR ATTENDANCE POLICY

A. ATTENDANCE

1. Attendance at conferences and seminars shall be limited to the Chairman and four additional members of the Board, the Executive Director, and a maximum of three employees to be determined by the Executive Director. The number of Board Members and employees authorized to attend may be limited to less than the amount specified in this resolution due to the availability of funds appropriated in the adopted Budget.
2. In order that all Board Members have an opportunity to participate in conferences and seminars, attendance shall be rotated among them.

B. EXPENSES

1. The Somerset Raritan Valley Sewerage Authority will assume the following costs, either paid directly or on a reimbursement basis for all Board Members and employees of the Authority previously authorized to attend a conference or seminar:
 - a. Registration Fees
 - b. Transportation costs, including mileage, at the rate established each year by the Internal Revenue Service, parking and tolls
 - c. Hotel accommodations
 - d. Meals and gratuities, not to exceed \$150.00 per day

2. The Somerset Raritan Valley Sewerage Authority will not assume the costs nor reimburse Board Members for any of the following:
 - a. Expenses incurred by a spouse or any other individual accompanying a Board Member or employee to a conference or seminar
 - b. Expenses for entertainment, sightseeing or alcoholic beverages
 - c. Expenses incurred by a Board Member or employee as a result of an election to travel to a conference destination prior to the start of the conference or to extend a stay beyond the end of the conference
3. All requests for reimbursement of authorized expenses shall be submitted to the Executive Director on an Authority voucher accompanied by receipts for same.


